Plus the courts themselves interfered with and stopped my form A appeal and doctor Roger's and others obstructed justice in many ways.

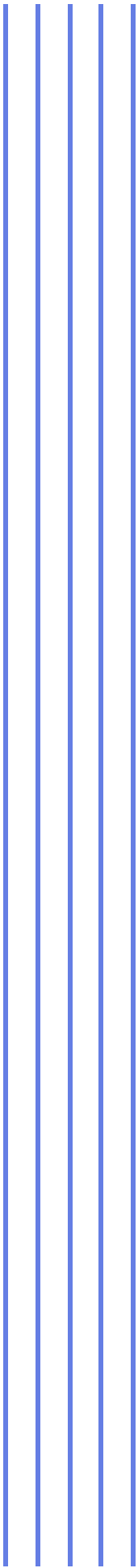
