In the alternative I intend to ask for grounds privileges (which is one of the things I am presently hunger striking for) and for the law (Section 26 of the HCCA) to be respected in case Dr. Tabitha Rogers intends to make good on her threat of using Section 25 to force treatment on me while my wish/advance directive is still alive, and my possessions to no longer be arbitrarily confiscated by staff (There is no certificate to manage property).

Perhaps a PEACE BOND?

I'll self represent Andrew, just including you on this email now that I have read the document you provided.

Rescheduling Requests:

- To reschedule this hearing, you must contact the other parties, or their lawyers if represented, and seek their agreement; if you do not have contact information for the other parties, please request it from the Board
- The Board should not be copied on discussions between the parties regarding rescheduling or other matters
- Mutual rescheduling requests must be made in writing and be copied to all other parties / lawyers
- Requests must specify the agreed upon new date and time, indicate the request is mutual, and include the case number and the original hearing date
- New dates and times for matters involving self-represented / unrepresented patients will only be considered at hearing
- All rescheduling requests are subject to the approval of the Board
- A hearing is not considered rescheduled until the Board has sent *notice* of the new date and time

Additional information regarding rescheduling uncontested Mandatory Form 48 hearings:

- If the patient has waived participation in the hearing a doctor may make a non-mutual rescheduling request
- Rescheduling requests must be made sent to the Board in writing at least 5 business days before the scheduled hearing
- All other conditions as described above apply

Note regarding Statutory Holidays: If “Day 7” falls on a stat holiday it shifts to the first business day following the stat. As a result, two days’ receipts of applications share “Day 7” (or three days’ receipts in the case of a double stat holiday). Due to this, during stat holiday periods, hearings will typically be scheduled for earlier than “Day 7” and the business days immediately before and after statutory holidays will not be available for rescheduling or adjournment.
