Greetings,

I have faxed a notice of abandonment of my appeal to the counsel for all parties, and the staff member that faxed them gave me the receipts.

I have no confidence in the Canadian legal system after all the times my right to self represent and get a fair trial have been interfered with by parties involved and the courts.

Canada forgot god.

Canada is lawless.

Psalm 9.

Furthermore, the longer this goes on, the more people will be involved in luring me into sin, and more frequently which is VERY SERIOUS (Luke 17:1-3) Out of love to others, which I must prioritize above myself, I insist on abandoning the appeal.

Dr. Rogers says she will not personally administer the first treatment but will give the order (***Il bacio della morte***) to a nurse.

Once my body which is a temple of the Holy Spirit is treated once more, I will stop eating and drinking as death is preferable than submitting to sin.

My alternate personalities threatened ultraviolence if this happens (so it is best I am kept in restraints until I die of thirst, as it would be WILDLY IRRESPONSIBLE to let me out of restraints), and I will try my best to kill myself even though I would have an orderly and am in a psychiatric prison. In order to continue to torture me (force me to submit to sin which has caused extreme emotional and psychological and spiritual distress and is internationally recognized as torture) dr. Rogers has threatened to have me force

fed and hydrated at the Ottawa hospital which would be an additional form of torture. God willing the call for the ambulance will be late, and I will be allowed to die.

When I die, parties involved will have participated in destroying a temple of God, in addition to luring me into sin, one of the reasons out of love to others I am abandoning the appeal.

Dr. Rogers is confident her treatment will result in me killing myself, this is not in my best interest, but she knows I am a Christian and she "dances with the Devil".

I forgive all parties involved in my state sponsored persecution and torture every offence no matter how small. I will beg God again to have mercy on them as scripture cannot be broken.

I hope some of them end up accepting Christ Jesus free gift so they will be my brother or sister forever and ever.

Even the notorious Babylonian king in the book of Daniel permitted him to not defile himself with the royal food.

Rhona and Gordon I am begging you not to show up, please do not respond.
