

I am in the gradual process of discharge planning (still in its infancy). I am thankful my suicide attempt failed given this new reasonably foreseeable hope.

Soon I will be looking for an apartment and a gym membership (swimming frequently, thereby combatting the lethal side effects of the pharmakeia and helping me integrate from my childhood satanic ritual abuse - it helped my big sister in Christ Fiona Barnett, and it has helped me).

Strategically it makes sense to be found mentally capable (as I have before after I was treated against my will, as capacity is fluid) and get off of the pharmakeia safely and entirely (following instruction and not going cold turkey in the last crucial steps) before I attempt to flee to another nation (since they have comparable laws and I would show up in the process of detoxing).

My new advance directive (wish) can be made more 'airtight' and indicate that I would prefer substantial decompensation and even indefinite hospitalization to being forced to submit to sin. There would be zero ambiguity, and I could even have it signed by out-patient doctor affirming I was presently capable.

My new advance directive can take into account Form D and Form E applications, and also specify, while I would then be clearly mentally capable (not under a finding of incapacity) that I would rather die from voluntarily stopping eating and drinking than submit to 'treatment' (Preferable to MAID as that involves pharmakeia)

I now have experienced first hand significant decompensating and a few lengthy hospitalizations first hand, so that could no longer be a reasonable argument used by opposing counsel.

Worst case scenario, as I would be able to self represent not under the effects of the pharmakeia, I could once again combat any attempts to torture me legally, and should that fail, have my preference of my right to die respected.

Praise the LORD.
